Communication improvements

- Intent is to outline improvements to communications related to Rio Tinto operations
- Formed Communication Working Group (CWG); two meetings
- CWG recommendations, supplemented by guidance at the Main Table are presented here for your review, revision, and confirmation
- Additional recommendations will flow from further discussion with agricultural interests

Communication improvements (2)

Overall guidance: "With the improvements directed through the Water Engagement Initiative (WEI), Table participants expect communication between Rio Tinto and interested parties to be:

- More collaborative: designed as an interactive partnership.
- Timely: where the information provided is useful for planning purposes and provides relevant information of upcoming changes.
- Inclusive: including local knowledge that exists in communities."

Communication Recommendation 1: Flow Facts

- Prior to the WEI, Rio Tinto used the Nechako Flow Facts to communicate operational information. The weekly Flow Facts included information on:
 - reservoir level;
 - Skin Lake spillway discharge;
 - Nechako River flow at Vanderhoof;
 - precipitation during the past week
 - precipitation forecast for the week ahead; and,
 - links to reservoir elevation, Skins Lake spillway, Nechako
 River at Vanderhoof, snowpack, and real-time river data.

Communication recommendation 1: Flow Facts

- During the WEI process, improvements were made to Flow Facts
- Received positive feedback
- Additional improvements to Flow Facts have been identified, and will include:
 - additional historical data on the Flow Facts website; and,
 - increased advertising in the community outlining that the information supporting Flow Facts can be obtained at any time from the Get Involved Nechako website.

Communication recommendation 1: Flow Facts

- Additionally, Rio Tinto is investigating:
 - automated Flow Facts updates; and,
 - automated flow projections.

Communication recommendation 1 for Table review, revision, and approval: WEI Table members support the information currently included in Flow Facts and support the additional improvements identified above.

Communication recommendation 2: Flood Emergency Planning

- During the WEI, participants recommended that Rio Tinto develop a Flood Emergency Plan (FEP). The overall intent is to:
 - outline the procedures to be followed when the likelihood of a flood is increasing;
 - confirm communication procedures;
 - identify roles and responsibilities; and,
 - outline opportunities for continual improvement.

Communication recommendation 2: Flood Emergency Planning

- Preliminary FEP components were identified as including:
 - identification of triggers for the activation of the FEP;
 - confirmation of communication mechanisms to be used to alert interested parties of emerging flood issues, such as social media, telephone calls, community postings, text messages and/or emails;
 - identification of processes used to update contact information for those with roles in the FEP

Communication recommendation 2: Flood Emergency Planning

- contact information for Indigenous communities and stakeholders who will receive the information;
- contact information for Rio Tinto emergency coordination representatives; and,
- the system to be used to keep contact information current.

Recommendation for Table review, revision, and approval: Rio Tinto representatives to initiate scoping efforts, conceptual design, and engagement regarding the FEP.

Communication recommendation 3: Team member awareness and communication efficiency

- WEI participants identified need for increased familiarity between Rio Tinto team members and representatives from municipalities, regional districts, and Indigenous communities that have roles that interact with Rio Tinto operations
- Rio Tinto currently holds face-to-face meetings with a range of groups on an annual basis

Communication recommendation 3: Team member awareness and communication efficiency

 Recommendation for Table review, revision, and approval: Rio Tinto to expand the list of municipal, regional district, and Indigenous communities to meet with on a defined basis to discuss Rio Tinto operations and relevant personnel. Rio Tinto to make information about their representative broadly available, e.g. this should be digital and posted in various locations and revised as personnel change.

Communication recommendation 4: Maintain "Get Involved Nechako Website

- Interests were expressed in having relevant and timely information about Rio Tinto operations
- WEI participants recommended the maintenance of the Get Involved Nechako website: https://www.getinvolvednechako.ca/
- Recommendation for Table review, revision, and approval: Rio Tinto to actively maintain the Get Involved Nechako website as an informational tool throughout and after the completion of the WEI.

Additional communication improvements

- Agricultural communication challenges to address:
 - Sufficient notification of water releases (ideally 7 to 10 days)
 - Need for seasonal schedule
 - Confirm most efficient communication mechanism
 - In-person meetings
- Key considerations relate to: irrigation schedules, haying times, fencing to control cattle or replacement of fences after the water has gone down

- Process to date: Meetings to date (in person, virtual due to COVID); presentations; introduction issues identification

- Adaptive management

Key themes (based on WEI Participant Survey)

- Good attendance and engagement by a diverse group
- Useful presentations
- Pace is slower than hoped, but realize the issues are complex, and people are passionate
- Trying to build practical solutions
- Living document and management with adaptive planning steps to answer the unanswered questions with science
- Long-term commitment needed
